- (3) There is no cost associated with this option as it is granted through an employee benefit plan. The option has a share value of \$8.97 per share based on the Black-Scholes valuation model.
- (4) Up to 1/3 of the shares covered by the option vest on 11/17/09, vesting increases to 2/3 of such shares on 11/17/10, and increasing to all shares on 11/17/11.
