- (2) Price is based on the closing market price for the securities on the New York Stock Exchange as of February 11, 2014.
- (3) The number of shares is arrived by dividing the closing price of the Issuer's securities on February 11, 2014 into \$70,000, the amount of the stock award granted to the Issuer's non-employee directors.
