The restrictions on these shares lapse upon the shorter of (a) five years from the date of grant or (b) until such time as the service of the recipient as a Non-employee Director of the Company shall have ended by reason of his or her (i) death or disability or (ii) failure to be reelected.
- (3) Price is based on the closing market price for the securities on the New York Stock Exchange as of February 11, 2014, the date on which Mr. Thorn was named to the Board of Directors.
